### RocTool Technologies used in production in North America

RocTool technologies continue reaching more applications and accelerate its developments with OEM and manufacturers in North America. The company is currently growing its presence in North America and counting more users. RocTool technologies are now used in production in North America. The platform in Charlotte, NC is becoming one of RocTool key technical centers for demonstrations and trials for injection molding, and soon for compression molding.
